CALGARY, July 16, 2012 /CNW/ - Crescent Point Energy Corp. ("Crescent Point" or the "Company") confirms that the cash dividend to be paid on August 15, 2012 in respect of July 2012 production, for shareholders of record on July 31, 2012 will be \$0.23 per share.
